## Duterte rallies support from business sector to fight corruption, red tape

MANILA -- President Rodrigo Roa Duterte has made a renewed call to the business sector to help his administration address corruption and red tape, which have been plaguing the country for decades and affecting its growth.

Fighting corruption, eliminating illegal narcotics trade, and criminality were President Duterte's major campaign pledges during the 2016 presidential election.

"I have tried my best day one of my administration to really do something about corruption. Good that we have now the ease of doing business," he said in a speech during the 45th Philippine Business Conference and Expo held at the Manila Hotel on October 17.

## US Border Patrol agents disrupt human smuggling scheme

SIERRA BLANCA, Texas— Border Patrol Agents apprehended 13 subjects being smuggled in the sleeper cabin of a tractor-trailer.

"This smuggling attempt reflects what little regard for life these human smugglers have," Big Bend Sector Chief Patrol Agent Matthew Hudak said. "Our agents' vigilance, training, and experience were vital in detecting and apprehending these individuals and prosecuting the smuggler."

On October 22, at approximately 4:30 a.m., while agents were conducting an immigration inspection on the driver of a tractor-trailer at the Sierra Blanca Checkpoint, a canine alerted on the truck. Upon referral to a secondary inspection area, agents discovered 13 individuals attempting to conceal themselves inside the sleeper cabin area of the truck.

It was determined that all of the subjects were illegally present in the United States and were citizens of Ecuador, Mexico, and Honduras. All of the smuggled aliens were processed according to applicable immigration laws. The case was turned over to U.S. Immigration and Customs Enforcement's (ICE) Homeland Security Investigations (HSI) El Paso, Texas. The driver and passenger were determined to be United States citizens and are being charged with alien smuggling, a felony.

Big Bend Sector Border Patrol agents patrol 517 miles of the southwest border that extends from Sierra Blanca, Texas to Sanderson, Texas.The Sierra Blanca Station area of responsibility consists of more than half of Hudspeth



County or about 2500 square miles. The station is responsible for 73 border miles between the U.S. and Mexico. More than 10,000 vehicles travel through the Sierra Blanca checkpoint on a daily basis. - *CBP*

FTC sends checks totaling more than \$31M to LifeLock customers The Federal Trade Commission will begin sending refund checks totaling more than \$31

million as part of a previously announced settlement with LifeLock, Inc. The refunds stem from a 2015 settlement LifeLock reached with the Commission, which

alleged that from 2012 to 2014 LifeLock violated an FTC order that required the commission, which alleged that from 2012 to 2014 LifeLock violated an FTC order that required the company to secure consumers' personal information and prohibited it from deceptive advertising. The FTC alleged that LifeLock failed to establish and maintain a comprehensive information security program to protect users' sensitive personal information, falsely advertised that it protected consumers' sensitive data with the same high-level safeguards used by financial institutions, and falsely claimed it provided 24/7/365 alerts "as soon as" it received any indication a consumer's identity was being used.

The FTC is mailing more than one million checks averaging about \$29. Recipients should deposit or cash checks within 60 days. Consumers who have questions about the re-funds should contact the FTC's refund administrator, Rust Consulting, Inc., at 1-866-898-5106. ## US Homeland Security agents and PNP-Transnational Criminal Investigative Unit agents rescue underage victims

MANILA — U.S. Homeland Security Investigations (HSI) agents and the Philippine National Police (PNP)-HSI Transnational Criminal Investigative Unit (TCIU) arrested two Philippine nationals and rescued seven minor victims during an anti-cybersex operation in Taguig, Philippines on October 21, 2019. The successful operation was the



result of close cooperation between Philippine and U.S. authorities.

HSI Manila, the PNP-HSI TCIU, and HSI Boston coordinated a real-time surveillance operation in the U.S. and the Philippines, which led to two arrests and the rescue of seven trafficked minor victims, ranging from 2 to 14 years of age.

This operation was supported by the Philippine Department of Social Welfare and Development, and the International Justice Mission, a non-governmental organization. HSI TCIUs are a partnership between HSI and local law enforcement units around the world that enhance host countries' ability to investigate and prosecute individuals involved in transnational crime.

The Philippines scored 90.63 from the 600,000 readers of the New York–based luxury and travel magazine.

It can be recalled that three islands of the Philippines made a splash in the CNT's list with Boracay, topping the Top Island Destination in Asia category, along with Cebu and Visayas Islands, and Palawan placing second and fourth, respectively.

"All these accolades that the country and our other island destinations continue to receive bode well for the country's sustainable tourism



development program as continuity is the very essence of sustainability," Secretary Puyat said.

Held at the One World Trade Center in New York City, DOT Attaché in New York Francisco M. Lardizabal received the awards on behalf of the Philippines.

#### Southern California doctor found guilty in \$12M Medicare fraud

A federal jury found a southern California doctor guilty for his role in a \$12 million scheme to provide medically unnecessary procedures to Medicare beneficiaries, upcode claims submitted to Medicare, and re-package single-use catheters for reuse on patients.

After a six-day trial, Donald Woo Lee, 54, of Temecula, California, was found guilty of seven counts of health care fraud and one count of adulteration of a medical device. Sentencing has been scheduled for March 19, 2020, before U.S. District Judge George Wu of the Central District of California, who presided over the trial.

According to evidence presented at trial, from 2012 to 2015, Lee engaged in a scheme in which he recruited Medicare beneficiaries to his clinics, falsely diagnosed the beneficiaries with venous insufficiency and provided the beneficiaries with medically unnecessary vein ablation procedures. The evidence further established that Lee billed these unnecessary procedures to Medicare using an inappropriate code in order to obtain a higher reimbursement, a practice known as "upcoding." In addition, the evidence showed that Lee repackaged used, contaminated catheters for re-use on patients. These catheters had been cleared by the FDA for marketing as single-use only. Lee submitted claims of approximately \$12 million to Medicare for the vein ablation procedures he performed, and received \$4.5 million as a result, the evidence showed.



## NASA astronauts wrap up historic all-woman spacewalk

On October 18, at 2:55 p.m. EDT, Expedition 61 Flight Engineers Christina Koch and Jessica Meir of NASA concluded their spacewalk, the first with only women. During the 7-hour, 17-minute spacewalk, the two NASA astronauts completed the replacement a failed power charging component, also known as a battery charge-discharge unit (BCDU). The BCDU regulates the charge to the batteries that collect and distribute solar power to the orbiting lab's systems. Mission control activated the newly installed BCDU and reported it is operating properly.


The astronauts were also able to accomplish some get-ahead tasks including installation of a stanchion on

the Columbus module for support of a new external ESA (European Space Agency) payload platform called Bartolomeo scheduled for launch to the station in 2020.

Commander Luca Parmitano of ESA and NASA Flight Engineer Andrew Morgan assisted the spacewalkers. Parmitano operated the Canadarm2 robotics arm and Morgan provided airlock and spacesuit support.

It was the eighth spacewalk outside the station this year. Space station crew members have now conducted 221 spacewalks in support of assembly and maintenance of the orbiting laboratory. Spacewalkers have spent a total of 57 days, 20 hours, and 29 minutes working outside the station.

It was the first spacewalk for Meir and the fourth for Koch, who now has spent a total of 27 hours and 48 minutes spacewalking. It is the first spaceflight for both women, who were selected in the 2013 astronaut class that had equal numbers of women and men. Koch arrived to the orbiting

> laboratory in March 2019 and will remain in space for an extended duration mission of 11 months to provide researchers the opportunity to observe effects of long-duration spaceflight on a woman to prepare for human missions to the Moon and Mars. Meir became the 15th woman to spacewalk, and the 14th U.S. woman. It was the 43rd spacewalk to include a woman. Women have been performing spacewalks since 1984, when Russian cosmonaut Svetlana Savitskaya spacewalked in July and NASA astronaut Kathryn Sullivan spacewalked in October.

> The faulty BCDU is due to return to Earth on the next SpaceX Dragon resupply ship for inspection. Station managers will reschedule the three battery replacement spacewalks for a future date. In the meantime, the five planned spacewalks to repair a cosmic particle detector, the Alpha Magnetic Spectrometer, are still on the calendar for November and December. - NASA

#### Awee Abayari: What is racism?

**RETIRED FBI SUPERVISORY SPECIAL AGENT CESAR** C. Awee Abayari: What is a hate crime?

**RETIRED FBI SUPERVISORY SPECIAL AGENT CESAR C. **Awee Abayari:** What do you think about the plan to create a "merit based " U.S. immigration system?

**RETIRED FBI SUPERVISORY SPECIAL AGENT CESAR** C. OLEGARIO, JR.: The idea of a merit-based immigration system would leave a good number of currently eligible immediate family petition applicants out in the cold. "Chain migration" currently approved under sponsorship by US citizens and legal permanent residents (LPR) would be overshadowed by a proposed merit-based system. The initiative places an unfair burden on families whom have legally earned legal status here in the United States, and closes the door on yet another legal venue to bring loved ones to the country as permanent residents. The family nucleus forms one of the major pillars which makes this country great and depriving the rights of "eligible Americans" from legally bringing other immediate family members from overseas is a travesty to "earned equal rights" of naturalized US citizens and LPRs. One issue I do have concern about as a side topic, is the milling of US citizens by foreigners who enter the United States for the sole purpose of having babies on US soil. Citizenship is undoubtedly a birthright if one is born in the United States, but it's difficult to ignore the large number of Chinese nationals applying for US passports for new born babies at the Los Angeles Regional Passport Agency. The loophole should be closed or at least regulated to prevent foreigners from entering the United States just to give birth to babies, and then quickly returning overseas with their new born US citizens. Nonetheless, I can't help but grin at my own comments, knowing that the parents of my childhood hero actively committed the same actions in San Francisco, California before they returned home to Hong Kong with their new born son Bruce Lee. In retrospect, Bruce Lee lived his life as a legendary American icon and was buried in Seattle, Washington.

**RETIRED FBI SUPERVISORY SPECIAL AGENT CESAR C. OLEGARIO, JR.:** I am in favor of President Trump imposing tariffs on China, but not necessarily in the manner being portrayed by the media. The Chinese are culturally different from Americans and it may be wise to approach the challenge accordingly. The US should stand its ground, but possibly impose tariffs and temper diplomacy based on a more Eastern philosophy. We approached the war in Vietnam all wrong without crediting the North Vietnamese for their resolve in the struggle, and we are still in Afghanistan refusing to accept the Afghanis are committed to the conflict for hundreds of years. Maybe we should approach the Chinese differently, and not expect them to quickly capitulate to the abruptness of our demands and perceived strength of our US economy. *Awee Abayari: Thank you for your service.* 



## U.S. Embassy launches restoration of Bastogne's Mardasson Memorial

To mark the 75th anniversary of the Battle of the Bulge, the sacrifices of American armed forces during World War II, and the generosity of the Belgian people, the U.S. Embassy to the Kingdom of Belgium announced the launch of a project to restore the Mardasson Memorial in Bastogne, Belgium.

U.S. Ambassador to the Kingdom of Belgium Ronald Gidwitz was joined by Minister of Justice Koen Geens, Bastogne Mayor Benoit Lutgen, and John Wessels of the American Battle Monuments Commission to announce the project.

The Mardasson Memorial was built to honor the sacrifices of American soldiers killed and wounded during the German Army's surprise Ardennes Offensive in December 1944 -January 1945. It is the only memorial that commemorates all American forces who fought in the Battle of the Bulge. Private Belgian citizens donated funds for its construction, which was inaugurated in 1950 in the presence of General Anthony McAuliffe, commander of the 101st Airborne Division during the defense of Bastogne.

"In my time as U.S. Ambassador, I have attended many commemorations throughout the country, and one thing always stands out. Belgium never forgets. The people of this country work tirelessly to keep the memory alive of

those who fought and died for their freedom," said Ambassador Gidwitz. "This is our way of expressing our gratitude to the people of Belgium for their decades of unwavering support and commitment to honoring our soldiers."

The U.S. Embassy is working with several partners on the project, including the Ministry of Justice and Building Agency and the City of Bastogne. The American Overseas Memorial Day Association created the Bastogne Memorial Fund to conduct fundraising in the United States. The American Battle Monuments Commission is managing the renovation project.

Koen Geens, Minister of Justice and Building Agency: "The commemoration of the Second World War and the honoring of victims who sacrificed their lives for the liberation of Belgium is close to your and my heart. I am grateful to the American government for investing in the renovation and restoration of the magnificent Mardasson Memorial on the 75th anniversary of the Battle of the Bulge. It is important to preserve this monument and to keep the memory of the war victims alive."

The first phase of the project includes extensive cleaning of the monument and crypt, as well as minor restoration of pavement stones. Phase I is scheduled for completion ahead of commemorative events set for December. Fundraising for a second phase and a more thorough restoration is already underway. The Bastogne Memorial Fund has collected more than 525,000 euros to date.

The Battle of the Bulge was the largest and bloodiest single engagement fought by American forces during World War II. The United States suffered nearly 90,000 casualties while 2,500 Belgian civilians lost their lives. -U.S.Embassy in Belgium

MANILA — As part of our deepening bilateral counterterrorism partnership, today, Philippine Police Chief General Oscar Albayalde and U.S. Ambassador to the Philippines Sung Kim broke ground on a new state-of-the-art Regional Counterterrorism Training Center in the Philippines.

The U.S. and Philippine governments will construct and operate the center on the grounds of the PNP Academy in Silang, Cavite. The U.S. Department of State has secured Php 520 million (\$10 million) in counterterrorism partnership funds to establish and jointly operate the center with the PNP.

Once constructed, the center will provide counterterrorism training for law enforcement units and personnel from the Philippines and regional partner nations. The initiative comes in response to a request from the PNP for a state-of-the-art facility to provide enhanced regional counterterrorism training. -U.S. Embassy in the Philippines relations. - Embassy of the People's Republic of China in the USA

## Forum with BSP governor spotlights ph economy's resilience

WASHINGTON, D.C.— "The Philippines has come a long way but it is now recognized globally as among the fastest growing and most resilient economies in the world. Its future prospects are bright. However, the transformation was a product of a long list of structural reforms. It did not happen overnight," declared Bangko Sentral ng Pilipinas (BSP) Governor Benjamin E. Diokno at a forum held at the Philippine Embassy in Washington, D.C. on 16 October 2019.

"The Bangko Sentral has always been the bulwark of continuity and stability. And we are honored to provide a platform in Washington DC for Governor Diokno to talk about the Philippine economy and our reform process. We are confident that with him guiding Philippine monetary policy, there will be continued business and investor confidence in the country," Philippine Ambassador to the United States Jose Manuel G. Romualdez said in a statement.

In his remarks, Governor Diokno emphasized that Philippine economic performance

is exceptional and sustainable, and powered through transformative reforms and political will. All the reforms - those undertaken in the past as well as being pursued today – are expected to support and sustain the currently favorable conditions of the economy that the Governor summarized in four key observations.

Economic growth is solid and sustainable. The Philippines recorded its 82ndconsecutive guarter of uninterrupted economic growth in the second quarter of 2019. Inflation has been reduced and within-target.

This is credited to a series of monetary actions by the BSP combined with administrative and legislative measures that addressed bottlenecks to food supply. Inflation fell to 0.9 percent in September 2019, and is expected to settle at 2.5 percent in 2019, and 2.9 percent for both 2020 and 2021.

The country's external position is also strong and is reflective of an economy driven by solid macroeconomic fundamentals and firm

growth prospects. This is on account mainly of the lower deficit in the trade-in-goods account; increased trade-in-services net receipts; and rising investor confidence resulting in higher foreign direct investments.

Finally, Governor Diokno noted that the robust and stable banking system likewise offers a sound basis for optimism. Banks remain sufficiently capitalized, and their past due ratios have consistently declined over the years.

Stability is also supported by financial sector reforms; cybersecurity and technology risk management; counter-terrorist financing; and capital market development.

Among the guests at the forum were Philippine Monetary Board Member Peter B. Favila, former US Ambassador to the Philippines Thomas Hubbard, BSP Deputy Governor Francis Dakila, other officials of the BSP, US government officials, US corporate executives, Embassy officers & staff, and some members of the Filipino-American community.

## World Tourism Organization discusses tourism sector trends and outlooks

MACAO, China – At the 2019 Global Tourism Economy Forum, the World Tourism Organization (UNWTO) has highlighted the importance of diversification, creativity and innovation for ensuring that the sector's unique potential as a driver of sustainable economic growth and social inclusivity is fully realized.

Government representatives and key public and private sector decision-makers met in Macao to explore the challenges and opportunities facing the global tourism sector today. The 2019 edition of the Global Tourism Economy Forum was held in line with the "Beautiful Life" initiative of Chinese President Xi Jinping, and Secretary-General Zurab Pololikashvili headed a group of UNWTO experts leading discussions over the course of the three days.

UNWTO announced the winner of the 1st UNWTO Sports Start-Up Competition, in partnership with Football Club Barcelona Innovation Hub and the Qatar National Tourism Council. Five start-ups, chosen from a field of more than 300 entrants from around the world. were invited to Oatar to pitch their ideas to investors and tourism sector leaders. They were judged on their level of market disruption, investment potential and ability to contribute to the Sustainable Economic Goals from Belgium was named as the overall winner.

UNWTO Secretary-General Zurab Pololikashvili said: "Macao is leading the way, showing the world how the digital transformation of tourism can make the sector more sustainable and more accessible. Smart tourism is key to managing the ongoing growth in tourism numbers in a responsible and sustainable way and ensuring that the many and varied benefits that come with this are felt as widely as possible." -- UNWTO

Sound familiar? Ads for envelope-stuffing "opportunities" can be anywhere — from your mailbox to your inbox, in the newspaper or on an online search. Promoters usually advertise that for a "small" fee, they'll tell you how to

earn big money stuffing envelopes at home. They may say you will earn money for each envelope stuffed, making it possible for you to earn hundreds — or even thousands — of dollars each week.

But when it comes to offers promising quick and easy income stuffing envelopes at home, be skeptical — and check it out.

According to the Federal Trade Commission (FTC), the nation's consumer protection agency, ads like these don't tell the whole story namely, that the promoters aren't really offering a job.

Promises of big earnings through an envelope-stuffing scheme are false. But if you are tempted to send any money or sign up to receive more information, ask the promoter: • Who will pay me?

• Where is your business located? • How long have you been in business? • How and when will I get my first

paycheck?

• Will I be paid a salary or will my pay be based on commission?

• What will I have to do?

· What is the total cost of the envelopestuffing program?

• What will I get for my money?

• Will I have to pay for supplies, ads or postage?

The answers to these guestions may help you determine whether an envelope-stuffing opportunity is appropriate for your circumstances.

It also may help to check out the company with your local consumer protection agency, state Attorney General and the Better Business Bureau in your community and the community where the company is located, which you can find at bbb.org. You can find out whether they've received complaints about the promotion that interests you, but remember — just because there aren't complaints doesn't mean the promotion is legitimate. Unscrupulous promoters may settle complaints, change their

If you've spent money and time on a work-at-home program and now believe it may be a scam, contact the company and ask for a refund. Let company representatives know that you plan to notify officials about your experience.

## Breaking the Cycle: Ms Gigi's Story

#### Shared from the Salvation Army

When Ms. Gigi and her two teenaged kids moved to Jacksonville from Louisiana. they came for a new beginning but quickly ran into trouble with rent she couldn't afford. They moved around from place to place for a while, but what they really needed was a safe and stable place to land while they got on their feet and Ms. Gigi finished school. A licensed LPN, Ms. Gigi is in night school to get her RN license. But this makes it difficult to find a job flexible enough for her school schedule and childcare needs.

After coming to the end of her options, she realized she needed to seek help.

"So I prayed. I did some research looking at different places. I started calling around and The Salvation Army was recommended to me. At the time we were in a hotel, but I knew that couldn't last long. When I got the word that a room was available at the Red Shield Lodge and we came here I didn't have a clue what to expect. But when we got here I saw that it was clean! It wasn't at all like what you see shelters looking like on T.V! I was shocked to see that we would have our own bathroom in the room, and we had a room, not a dormitory. We had privacy. I was like, 'Wow, this is going to be good!' I believe without a doubt that this is where the Lord really wanted us to be at this time to get some things together."

"At first it was hard for my daughter. She didn't want her friends to know that she was in a shelter. But I told them it's temporary to help us get where we need to be. It was hard for me to see her cry. But then I prayed and a song came on her playlist. It said everything was going to be alright. From then on she was fine and started telling her friends, "I'm at The Salvation Army".

At The Salvation Army Ms. Gigi and her family are finding more than just a safe place to stay. They also feel great support and community from the other residents at the shelter.

"I like that The Salvation Army is based



on the Gospel of Jesus Christ. That's something that I really love. We have the opportunity – the ladies who want to – we get together and pray. And then we have Bible study. We started meeting after lunch in the family room and going over the Daily Bread and praying together. I've been looking at the different people here and, you know, all of us come from different backgrounds. Everybody has something different going on in our lives and we need different things. This place is about more than just having a place to live – we have inner things that need to be dealt with. If we get that taken care of, then once we leave we won't have to come back. We won't go thought that cycle over and over. This is about breaking the cycle."

This time next year Ms. Gigi says her dream is to be graduated from her RN program and feeling settled in Jacksonville. She also wants to continue to help the women at the Red Shield Lodge shelter. "Even after I leave I want to come back and help minister to the people who are here to help move them along. And I believe my testimony will be all the stronger because I can say, 'Oh no, I DO know. I was in room 116'. I lived the story."



**Department of Homeland Security** (DHS) has unveiled a new security-enhanced travel document that has looks similar to a US passport.


The agency says the new document, which went into production on October 24th, has more features to prevent tampering, counterfeiting and fraud.


USCIS, an agency within the Department of Homeland Security, says the new travel document can serve in place of:

• Form I-327, Permit to Reenter the United States: Lawful permanent residents use the Reentry Permit to return from temporary travel outside of the United States and, in some cases, may use a Reentry Permit for travel in place of a passport; and

• Form I-571, Refugee Travel Document:

**Redesigned booklet cover** 

Four montages containing three images, each of notable U.S. architecture, used throughout the booklet

A combination of first-, second- and third-level security features (overt, covert and forensic)

Overt is something you can see with the eye, such as the central image of the Statue of Liberty.

Covert is something that requires a tool, such as a magnifying glass, to see fine detail artwork.

Forensic is something that requires laboratory examination.

USCIS says previous versions of the travel document will remain valid until their expiration date.

## Sleepiness and Driving Don't Mix

Feeling sleepy is especially dangerous when you are driving. Sleepiness slows your reaction time, decreases awareness and impairs your judgment, just like drugs or alcohol.

People who are very sleepy behave in similar ways to people who are drunk. The impact that this has on traffic safety should not be underestimated.

To remain alert and avoid drowsiness, AAA suggests:

• Getting plenty of sleep (at least six hours) the night before a long trip;

• Traveling at times when you are normally awake, and staying overnight rather than driving straight through;

· Scheduling a break every two hours or every 100 miles;

 Stop driving if you become sleepy; someone who is tired could fall asleep at any time - fatigue impacts reaction time, judgment and vision, causing people who are very sleepy to behave in similar ways to those who are drunk:

· Not planning to work all day and then drive all night;

• Drink a caffeinated beverage. Since it

takes about 30 minutes for caffeine to enter the bloodstream, find a safe place to take a 20-30 minute nap while you're waiting for the caffeine to take effect;

· Avoid sleepy times of day. Take a mid-afternoon nap and find a place to sleep between midnight and 6 a.m.; and • Traveling with an awake passenger.

Symptoms of sleepiness include but are not

limited to: • Having trouble keeping your eyes open and focused;

• The inability to keep your head up; · Daydreaming or having wandering,

disconnected thoughts;

- Drifting from your lane or off the road, or tailgating;
- · Yawning frequently or rubbing your eyes repeatedly;

· Missing signs or driving past your intended exit;

Feeling irritable and restless; and

 Being unable to remember how far you have traveled or what you have recently passed. Source: AAA

## News Briefs

#### Border patrol seizes over \$850,000 of meth

ALAMOGORDO, N.M. - On October 19 U.S. Border Patrol agents at a checkpoint north of El Paso, seized narcotics worth more than \$800,000 from a single vehicle.

While conducting a routine immigration inspection, Border Patrol Agents stopped a gray Saturn Vue for further investigation. Agents interviewed the driver, a United States citizen.

Border Patrol agents then conducted a thorough search of the vehicle and found 17 bundles wrapped in clear cellophane and tin foil - a type of concealment method often used by narcotics smugglers. The bundles contained over 25 pounds of methamphetamine. The street value of the meth is estimated at more than \$850,000. The vehicle was seized by the United States Border Patrol; the driver and narcotics were turned over to DEA.

Checkpoints located outside the El Paso area serve as a secondary line of defense. Drug seizures like this one keep these dangerous drugs from polluting communities in the interior of our nation. - CBP

Guam ambulance company executives plead guilty to Medicare

Two former owners and an employee of an ambulance services provider headquartered in Guam pleaded guilty yesterday for their roles in a health care fraud and money laundering scheme that resulted in a loss to the United States of approximately \$10.8 million.

This is one of the largest single Medicare ambulance fraud cases prosecuted nationwide.

Assistant Attorney General Brian A. Benczkowski of the Justice Department's Criminal Division, U.S. Attorney Shawn N. Anderson of the Districts of Guam and the Northern Mariana Islands, Special Agent in Charge Eli S. Miranda of the FBI's Honolulu Field Office, Special Agent in Charge Justin Campbell of IRS Criminal Investigation's (IRS-CI) Seattle Field Office and Special Agent in Charge Timothy DeFrancesca of the U.S. Department of Health and Human Services Office of the Inspector General's (HHS-OIG) Los Angeles Regional Office made the announcement.

Shoemake, 31, of Guam, the former owners and an employee, respectively, of Guam Medical Transport (GMT), pleaded guilty before U.S. District Judge Frances Tydingco-Gatewood of the District of Guam, to one count of conspiracy to commit health care fraud and one count of conspiracy to engage in monetary transactions with the proceeds of specified unlawful activity. The defendants are scheduled to be sentenced on Jan. 29, 2020.

#### Man arrested for attempting to illegally export controlled items to Libya

Peter Sotis, 55, of Delray Beach, Florida, was arrested yesterday based on an indictment charging him with conspiracy to violate and attempted violation of the International Emergency Economic Powers Act (IEEPA) and the Export Administration Regulations (EAR), as well as smuggling of goods.

John C. Demers, Assistant Attorney General for National Security; Ariana Fajardo Orshan, U.S. Attorney for the Southern District of Florida; Robert Luzzi, Special Agent in Charge of the Department of Commerce's Office of Export Enforcement (DOC) Miami Field Office; and Anthony

Salisbury, Special Agent in Charge of U.S. Immigration and Customs Enforcement's Homeland Security Investigations' (ICE-HSI) Miami Field Office, made the announcement.

The indictment alleges Sotis was the owner and principal of Add Helium, a Fort Lauderdale diving company. Sotis was charged with smuggling, conspiracy to violate and attempted violation of the IEEPA and the EAR by transferring dual-use goods, that is, articles that have both civilian and military application, for export to Libya without the required Department of Commerce license.

Four Continental Events and a final World Qualification Event will be held between February and May 2020 to give boxers the opportunity to seal their places at the Tokyo 2020 boxing tournament.

The World Qualification Event will give athletes a second chance to qualify and will therefore be open only to those boxers who have not yet qualified for the Games. "The Qualification Events represent a fair and transparent pathway to the Olympic Games with equal opportunities for all National Olympic Committees," said



Boxing Task Force Chair and IOC Member Mr Morinari Watanabe. "Everything is being done to provide worldclass Qualification Events and to ensure the best possible conditions for the athletes."

## SKATE AMERICA DEBUTS IN LAS VEGAS

### L.A. Convention Center unveils largest public art & civic project in the country by Portraits of Hope

The mural, spanning the length of four football fields, and accompanying artwork will be displayed for approximately six months on the LACC's South Hall facing the 110 freeway and on the ground level of the facility in and around the West Hall parking garage and walkway facing STAPLES Center.

#### • BUILD A KIT

Make sure your emergency kit is stocked with the items on the checklist below. Most of the items are inexpensive and easy to find, and any one of them could save your life. Headed to the store? Download a printable version to take with you. Once you take a look at the basic items, consider what unique needs your family might have, such as supplies for pets, or seniors.

After an emergency, you may need to survive on your own for several days. Being prepared means having your own food, water and other supplies to last for at least 72 hours. A disaster supplies kit is a collection of basic items your household may need in the event of an emergency.

#### • BASIC DISASTER SUPPLIES KIT

To assemble your kit, store items in airtight plastic bags and put your entire disaster supplies kit in one or two easy-to-carry containers such as plastic bins or a duffel bag.

A basic emergency supply kit could include the following recommended items:

Water - one gallon of water per person per day for at least three days, for drinking and sanitation

Food - at least a three-day supply of non-perishable food Battery-powered or hand crank radio and a NOAA Weather Radio

Flashlight

First aid kit

Extra batteries

Whistle to signal for help

Dust mask to help filter contaminated air and plastic sheeting and duct tape to shelter-in-place

Moist towelettes, garbage bags and plastic ties for personal sanitation

Wrench or pliers to turn off utilities Manual can opener for food Local maps

Cell phone with chargers and a backup battery

#### ADDITIONAL EMERGENCY SUPPLIES

Consider adding the following items to your emergency supply kit

Prescription medications

Non-prescription medications such as pain relievers, anti-diarrhea medication, antacids or laxatives

Glasses and contact lense solution

Infant formula, bottles, diapers, wipes, diaper rash cream

Pet food and extra water for your pet

Cash or traveler's checks

Important family documents such as copies of insurance policies, identification and bank account records saved electronically or in a waterproof, portable container

Sleeping bag or warm blanket for each person

Complete change of clothing appropriate for your climate and sturdy shoes

Household chlorine bleach and medicine dropper to disinfect water Fire extinguisher

Matches in a waterproof container

Feminine supplies and personal hygiene items

Mess kits, paper cups, plates, paper towels and plastic utensils Paper and pencil

Books, games, puzzles or other activities for children

#### MAINTAINING YOUR KIT

After assembling your kit remember to maintain it so it's ready when needed:

Keep canned food in a cool, dry place

Store boxed food in tightly closed plastic or metal containers

Replace expired items as needed

Re-think your needs every year and update your kit as your family's needs change.

#### • KIT STORAGE LOCATIONS

Since you do not know where you will be when an emergency occurs, prepare supplies for home, work and vehicles.

Home: Keep this kit in a designated place and have it ready in case you have to leave your home quickly. Make sure all family members know where the kit is kept.

Work: Be prepared to shelter at work for at least 24 hours. Your work kit should include food, water and other necessities like medicines, as well as comfortable walking shoes, stored in a "grab and go" case.
