#### Credit Suisse's Investment Bank in HK to pay \$47-M criminal penalty for corrupt hiring scheme

redit Suisse (Hong Kong) Limited (CSHK), a Hong Kong-based subsidiary of Credit Suisse Group AG (CSAG), a Swiss-based issuer of publicly traded securities in the United States, reached a resolution with the Department of Justice and agreed to pay a \$47 million criminal penalty for its role in a scheme to corruptly win banking business by awarding employment to friends and family of Chinese officials, the Justice Department announced

The employment of these "relationship hires" or "referral hires" was part of a guid pro guo with the officials who referred the candidates for employment, whereby CSHK bankers sought to and did win business from the referral sources.

HIDALGO, Texas - U.S. Border Patrol agents assigned to the Weslaco station encountered a group of 31 illegal aliens along the riverbank of the Rio Grande near Hidalgo, Texas.

#### USCIS recalls incorrectly printed employment authorization documents

On June 21, 2018, USCIS began recalling approximately 800 Employment Authorization Documents (EADs) that were issued in conjunction with Form I-589, Application for Asylum and for Withholding of Removal, which were granted by USCIS asylum officers. The cards contain a production error that transposed the first and last names of the individuals receiving the EADs. These cards were mailed to recipients in April and May 2018. Affected individuals should return their incorrect EADs to USCIS within 20 days of receiving the notice.Replacement EADs will be sent within 15 days of receiving the incorrect card.

# National health care fraud takedown

601 defendants charged, more than \$2 billion in fraud losses recorded

FBI Deputy Director David Bowdich took part in a press conference with U.S. Attorney General Jeff Sessions, Health and Human Services (HHS) Secretary Alex Azar III, and other federal officials to announce a nationwide health care fraud and opioid takedown that has resulted in charges against 601 defendants around the country, along with a total of more than \$2 billion in fraud losses.

This takedown, the largest health care enforcement action taken to date by the joint Department of Justice and HHS Medicare Fraud Strike Force, involved numerous federal and state agencies working together on the front lines in the fight against health care fraud. "But our work is not finished—we are just getting started," said Sessions. "We will continue to find, arrest. prosecute, convict, and incarcerate fraudsters and drug dealers, wherever they are."

# Duterte's 3rd SONA not limited to accomplishments, Roque says

ANILA -- President Rodrigo R. Duterte's third State of the Nation Address (SONA) will not be limited to a report on the achievements done during his administration, his spokesperson said.

Presidential spokesperson Harry Roque reiterated that Duterte's next SONA scheduled on July 23 (Monday) will be delivered "straight from the heart."

"I think they want it to be a message straight from the heart of the President not hindered by the need to report on the different achievements," Roque said in a Palace briefing. Roque said the public will get a preview of the policies, programs and projects implemented during Duterte's second year in office through a series of pre-SONA forums.

"One difference is magkakaroon po ng (there will be) pre-SONA briefings ivong mga (in) economic clusters that will be held in PICC. That's to give the President latitude to say whatever he wants during the SONA, because he has already laid out his achievements in the different clusters. Roque said

"The different achievements will be reported by the different clusters in the different pre-SONA briefings that will be conducted," he added.

# CAYETANO, POMPEO MEET; **VOW TO REINFORCE PH-US TIES**

ASHINGTON, D.C. - Foreign Affairs Secretary Alan Peter S. Cayetano and Secretary of State Mike Pompeo met for the first time on 21 June 2018, and both diplomats agreed to work closely together to further reinforce the partnership between the Philippines and the United States.

"Secretary Cayetano and Secretary Pompeo had an open and cordial interaction at the State Department today and we are optimistic this would reinforce the ties that bind the relations between our two countries and peoples," Ambassador to Washington Jose Manuel Romualdez said.

During the meeting that was also participated in by National Security Adviser Hermogenes Esperon, Jr., Secretary Cayetano and Secretary Pompeo underscored the importance both the Philippines and the United States place on their shared historical and people-to-people

ties and the strength of their defense alliance. Ambassador Romualdez said the

meeting also allowed Secretary Cavetano the opportunity to share with his counterpart the independent foreign policy of the Duterte Administration and its positions on such issues as the South China Sea and the Korean Peninsula.

During the meeting, both Secretary Cayetano and Secretary Esperon conveyed to Secretary Pompeo Manila's appreciation for the assistance and cooperation extended by the US in various areas, including counterterrorism and the rehabilitation of Marawi.

Ambassador Romualdez said Secretary Pompeo expressed hope for another meeting between President Duterte and President Trump as a follow up to the productive and warm friendship that the two leaders developed during the Philippine hosting of the ASEAN Summit in Manila last November.



The charges announced aggressively targeted schemes billing Medicare, Medicaid, TRICARE (a health insurance program for members and veterans of the armed forces and family members), and private insurance companies.

# New data shows criminal arrest histories of DACA requestors

WASHINGTON—U.S. Citizenship and Immigration Services (USCIS) released new data regarding arrests and apprehensions among the Deferred Action for Childhood Arrivals (DACA) requestor population.

The data contains both criminal and civil information of those approved and denied under DACA.

The findings are part of a continuous release of information by the agency to its website on both the DACA policy and its requestor population. The new data relates to arrests and apprehensions, which do not necessarily result in actual convictions.

Among the findings of the release:

Almost 8-percent of total DACA requestors (59,786

"Requestors" includes individuals approved and denied DACA.

 Of those individuals whose DACA requests were approved and had one or more arrests or apprehensions, 53,792 were arrested or apprehended prior to their most recent approval.
Approximately 13-percent (7.814) of approved

DACA requestors with an arrest had an arrest after their grant was approved and prior to renewal.

• 54.8-percent of DACA requestors with more than one arrest (17,079) most recently had a DACA case status of "approved" as of the date the systems were queried.

• 199 individuals who requested DACA had 10 or more arrests. Of those, 51 most recently had DACA case status of "approved," as of the date the systems were queried.

 Of the total 888,765 DACA requestors, 797,297 had no arrests or apprehensions, and 710, 842 were approved. Under current DACA policy, an individual may be con-

sidered for DACA if he or she has not been convicted of a felony, significant misdemeanor, or three or more "non-significant" misdemeanors not arising out of the same act, omission, or scheme of misconduct, or does not otherwise pose a threat to national security or public safety. Numbers of arrests alone do not necessarily disqualify a person from receiving DACA as a matter of discretion.

### Statement from DHS Press Secretary on June border numbers

Department of Homeland Security (DHS) Press Secretary Tyler Q. Houlton released the following statement on U.S. Customs and Border Protection's (CBP) Southwest Border Migration numbers for June:

"Following the implementation of the Administration's zero-tolerance policy, the June 2018 Southwest Border Migration numbers declined by 18 percent when compared to the previous month.

"DHS will continue to enforce the rule of law and uphold our nation's immigration laws as passed by Congress. As we have said before, the journey north is dangerous and puts individuals in the hands of smugglers and traffickers. We continue to call on Congress to address the crisis at the border by closing legal loopholes that drive illegal immigration."



**Awee Abayari :** How would you assess the June 12 US- North Korea Summit?

Retired FBI Supervisory Special Agent Cesar C. Olegario, Jr. : The summit between POTUS and the Supreme Leader of North Korea went very well. I feel that President Trump made a positive impact and the initial way forward for both leaders was established. It seems as though both leaders had managed to reveal goals for both countries and discuss their general expectations. What the public must realize is that resolutions to major issues such as nuclear weapons and international sanctions will not be achieved as result of the historic first meeting in Singapore. Senior members of both governments will continue to work diligently to resolute matters as a precursor to detailed and actionable peace agreements. I might add that I was somewhat disappointed by how the media downplayed the impact of the meeting by focusing on the perception nothing was resolved.

On the contrary, POTUS going through with the meeting signified the United States was taking the Supreme Leader seriously. What better way to make progress towards peace, than to show mutual respect and understanding for the head of an Asian country by taking him seriously? We all know how important respect is heavily weighed in Asia and Asian society.

Awee Abayari : Please comment on the new travel ban that "indefinitely limits travel from Iran, Libya, Syria, Yemen, Somalia, Chad and North Korea". Certain government officials from Venezuela were also barred.

Retired FBI Supervisory Special Agent Cesar C. Olegario , Jr. : The travel ban is restricted to tourists and other types of lower tier visas. Persons who are legally already in the U.S. are still afforded with the opportunity to petition immediate family members and submit other like applications.

The applicants for more permanent types of visas directly impacting documented families are subjected to different levels of screenings in the application process. The travel ban prevents the likelihood of individuals wishing to do harm to the United States, will be able to do so by traveling and entering the country. The United State government has selected such mentioned countries for inclusion in the travel ban based on intelligence and threat matrices inherent to potential threats and risks posed to the United States.

Awee Abayari : "Opponents say the ban violates the U.S. Constitution because it discriminates against Muslims while overstepping the bounds of U.S. immigration law by discriminating by nationality. Trump has said the restrictions are needed to tighten security and prevent terrorist attacks".

Muslims. It just so happens that a majority of the population from those countries are Muslims. Of course, with the exception of North Korea. President Trump has endorsed the travel ban under the banner of national security. Individuals and groups from those countries wish to do harm to the United States and the President of the United States has not "made up" the short list based on casual dinner conversation. The countries have been selected based on a clear and present danger presented by the general populace whom largely happen to be Muslim. We must never forget that "All men are created equal" but yet come to the realization that some countries have a larger population with people who seem to hate us more than others. Additionally, I'm sure the Trump administration has taken into consideration efforts (or lack thereof) by such respective governments to curb insurgency and international terrorism threats potentially impacting the United States

Awee Abayari: Should the probe of Russian interference in the 2016 presidential election by the former FBI Director Robert Mueller continue ? Why ?

Retired FBI Supervisory Special Agent Cesar C. Olegario, Jr. : Former FBI Director Robert M. Mueller III is a man of strong integrity and even stronger conviction. The probe must continue if the American people are to learn the truth behind allegations of Russian interference with U.S. elections in 2016. Several significant indictments and outcomes have already resulted from such efforts and I am confident resolution to the sensitive matter will be forthcoming in the investigation. The former FBI Director is a no nonsense man who is more than capable of revealing the truth no matter the political obstacles which may stand in his way.

Awee Abayari: President Trump has denied any collusion by his campaign and has long denounced the Mueller probe as a witch hunt. Do you believe him ?

Retired FBI Supervisory Special Agent Cesar C. Olegario, Jr.: It's possible President Trump may not have taken direct action in the alleged presidential elections scandal of 2016. It's also possible persons on his staff may have been closely involved in the scandal. Nonetheless, a leader is also responsible for actions taken by those persons whom he has placed in authority, such as selected senior members authorized to help win the presidential election. Candidate Trump of 2016 was involved in a myriad of details focused on the election. I believe President Trump may possibly not have knowledge to sustain allegations of Russian interference in the 2016 elections, but senior members previously involved in his election campaign may not come out as unscathed from the investigative probe.

### France calls on Russia to enforce the commitment agreed to on the ceasefire


' tatement issued by the ministry of Europe and Foreign Affairs about the situation in Southwestern Syria:

"France is extremely concerned by the offensive conducted by the Syrian regime and its backers in southwestern Syria, especially around the city of Deraa, in violation of the deescalation agreement that is supposed to guarantee the stability of this area. These attacks create a risk of escalation and regional destabilization

"We are especially attentive to the humanitarian conseauences of this offensive on the civilian population and to attacks on medical and healthcare infrastructures, which constitute serious violations of international humanitarian law. These operations forced nearly 45,000 people to flee. These latest displaced persons join nearly a million people displaced by the conflict since early 2018. This is the largest movement of displaced persons since the beginning of a conflict that has already forced more than half of all Syrians to leave their homes.

"That is why France is calling on Russia to enforce the commitments it agreed to on the cease-fire in southwestern Syria.

"The latest events underscore the urgent need to establish a credible political process under the auspices of the UN and in accordance with Security Council resolution 2254, allowing the Syrian parties and main international stakeholders to agree on the parameters for sustainably ending the crisis. To that end, France supports the efforts of the UN special envoy to establish a constitutional committee and to create the necessary convergences within the international community."

You Could Receive Benefits from Class Action Settlements

Settlements have been reached with four airlines in class action lawsuits involving the price of airline tickets. The Settling Defendants are: Air New Zealand, China Airlines (Taiwan), EVA Airways, and Philippine Airlines. Settlements were previously reached with 8 Defendants. The lawsuit continues against the remaining Non-Settling Defendant airline: All Nippon Airways ("ANA").

#### What is the case about?

The lawsuits claim that the Defendants agreed to fix prices on tickets for transpacific air travel. As a result, ticket purchasers may have paid more than was necessary. The Settling Defendants deny the allegations and deny that they have any liability. The Defendant airlines also deny liability, although ANA has pled guilty to fixing the prices of certain discounted tickets.

#### Am I included?

You are included if: (1) you bought a ticket for You must submit a Claim Form online or by

ticket claimed. This does not include amounts that will be paid on any future settlement or judgment involving ANA. Claims from the earlier round of settlements have not yet been audited. As a result, the number of claimed tickets that are determined to be eligible may be reduced, and the corresponding amount of compensation to be allocated among the remaining eligible claims will increase. Additional information is available on the website below. Class Counsel will pursue the lawsuit against the Non-Settling Defendant.


Class Counsel have not requested attorneys' fees and reimbursement of costs at this time but will do so in connection with the final approval hearing. For the current Settlements, Class Counsel will request up to one-third of the Settlement Fund plus up to \$7,500 for one additional class representative.

## **Premier Li and French PM meet the press** For his part, Philippe said the high-level relations

On June 25, 2018, Premier Li Kegiang and French Prime Minister Edouard Philippe met the press and answered questions after their meeting.

The two leaders spoke highly of their results of cooperation in areas such as nuclear energy, aerospace, agricultural food and cultural exchanges



Premier Li called on all countries, including China and France, to support trade liberalization and investment facilitation, and maintain multilateralism and an open world economy when trade protectionism and unilateralism are rising.

Trade surplus is not what China pursues, and economic and trade exchanges should largely be carried out according to market rules and business principles, the Premier said. He added that the existing frictions and disputes should be addressed through negotiations based on the principle of mutual respect, equality and mutual benefit. T

The foundation for the world economic recovery, which has not come easily, is still weak, the Premier said, urging countries to work together for trade growth rather than trade barriers and protectionism.

China is ready to join hands with all parties to maintain multilateralism and a free trade system, oppose literalism and protectionism, and maintain the stability and growth of the global economy and trade, he said.

# "Critical Thinking is Key in the Age of Fake News"

In honor of World Press Freedom Day, the Austrian Cultural Forum Washington and the Press and Information Service of the Embassy of Austria hosted a panel discussion entitled Freedom of the Press: Still the 4th estate? featuring Washingtonbased reporters Paul Farhi (The Washington Post), Evan McMorris-Santoro (Vice News) and John Walcott (Reuters), as well as Hannelore Veit (ORF - Austrian Broadcasting Corporation) and Eric Frey (Der Standard) from Austria.

The panel, moderated by Ms. Veit, aimed to assess the role of the media as a watchdog on both sides of the Atlantic. It



was introduced by a presentation on the reach of U.S. news media and the divide among audiences, given by Katerina Matsa from the Pew Research Center. One of the take-aways of the event was the pivotal role of media literacy and critical thinking in the age of

so-called "fake news" media. The panel was the inaugural event of the Salon Series (Salongespräche) of the Austrian Cultural Forum Washington and also part of this year's celebrations of the 180th anniversary of Austrian-American Diplomatic Relations, the 70th anniversary of the Austrian Press and Information Service, the Commemorative Year 2018 (i.a. 100 years of the Republic of Austria's founding post WWI), and the upcoming Austrian EU-Presidency in the second half of 2018.

Economic partnership agreement At the EU-Japan summit of 6 July 2017, both parties reached agreement in principle on the main elements of a free trade deal, known as the economic partnership agreement (EPA).

The EPA is a highly ambitious and comprehensive trade agreement. When fully implemented, 99% of the tariffs applied on EU exports to Japan, which currently amount to about €1 billion, will be removed.

The agreement will create sizeable new opportunities for EU agricultural exports, removing the existing Japanese tariffs on products such as cheeses or wines, while protecting EU intellectual property rights on Japanese markets. It will also open up services markets and significantly increase EU companies' access to Japan's procurement bids.

The EPA is based on the highest standards of labour, safety, environment and consumer protection. It is also the first trade agreement including a specific commitment to the Paris climate agreement.







# **Avoiding World Cup scams**

he long-awaited 2018 World Cup is underway. Fans from across the world have flocked to Russia in support of their favorite teams. Though most have already bought their tickets, many are still hoping to come across an unbeatable deal that will get them to the Cup.

While fans hope for a good deal, scammers hope for ticket-hungry fans. Here are a few tips for avoiding World Cup-related scams:

• Ignore any email that claims you've won World Cup tickets or a lottery prize to attend the Cup. The offer may seem promising, but the truth is, scammers are simply phishing for your personal information. Never open files or click on links sent by strangers. And never pay a fee to

claim a prize.

• FIFA.com is the official source for tickets. If you choose to buy tickets from a reseller or ticket broker, you run the risk of your tickets not arriving in time for the match, not arriving at all, or being invalid. Paving by credit card gives you protections, such as the right to dispute charges for items that you paid for, but never received.

• Buying team apparel? Scammers often create fake online stores. Read reviews to see what people are saying about the seller or the website. Search online using the seller's name or website with terms like "reviews," "scam" or "complaint."

he FTC is warning consumers to watch out for vacation rental scams. The agency has published a blog post, Getting a vacation rental? Watch out for scams, with a message for consumers who are looking to book a summer rental: Scammers are ready with fake vacation



rental ads, and their plan is to take your money and leave you with no place to stay. The blog post explains how vacation rental scams operate and includes a list of tips on how to avoid them. The blog also encourages consumers who come across any scam rental ads to report them to the FTC.

**FROM THE FBI** HEALTH CARE FRAUD OR HEALTH INSURANCE FRAUD

ealth care-related schemes attempt to defraud private or government health care programs, which usually involve health care providers, companies, or individuals. These schemes may include offers for (fake) insurance cards; health insurance marketplace assistance; stolen health information; or medications, supplements, weight loss products, or pill mill practices.

The FBI seeks to identify and pursue investigations against the most egregious offenders involved in health care fraud through its investigative partnerships with federal, state, and local agencies, as well as its relationships with private insurance national groups, associations, and investigative units.

#### **Common Fraud Schemes**

Medical Equipment Fraud: Equipment manufacturers offer "free" products to individuals. Insurers are then charged for products that were not needed and/or may not have been delivered.

"Rolling Lab" Schemes: Unnecessary and sometimes fake tests are given to individuals at health clubs, retirement homes, or shopping malls and billed to insurance companies or Medicare.

Services Not Performed: Customers or providers bill insurers for services never rendered by changing bills or submitting fake ones.



Medicare Fraud: Medicare fraud can take the form of any of the health insurance frauds described above. Senior citizens are frequent targets of Medicare schemes. Because a physician has to sign a form certifying that equipment or testing is needed before Medicare pays for it, con artists fake signatures or bribe corrupt doctors to sign the forms. Once a signature is in place, the manufacturers bill Medicare for merchandise or service that was not needed or was not ordered.

**Tips for Avoiding Health Care Fraud** or Health Insurance Fraud

Never sign blank insurance claim

forms. Never give blanket authorization to a medical provider to bill for services rendered.

Ask your medical providers what they will charge and what you will be expected to

Carefully review your insurer's explanation of the benefits statement. Call your insurer and provider if you have questions.

Do not do business with door-todoor or telephone salespeople who tell you that medical services or equipment are free.

Give your insurance/Medicare identification only to those who have provided you with medical services.

Keep accurate records of all health care appointments.

 Know if your physician ordered equipment for you.

 Do not open spam e-mail, Internet advertisements, links in forums or social media, and questionable websites that promise health care-related goods or services that seem too good to be true, as they likely are fraudulent.



### FTC sends refund checks totaling more than \$214,000 to people who bought deceptively marketed bed bug treatment

he Federal Trade Commission is mailing 852 refund checks, totaling more than \$214,000, to consumers nationwide who bought bed bug



and prevent bed bug infestations. Each check recipient is receiving 95% of the amount they spent on these treatments. The average check amount is \$251. These checks must be cashed within 60 days of the date they are issued or

The refunds stem from a January 2018 complaint against Chemical Free Solutions LLC (CFS), the seller of Cedarcide Original, a line of products deceptively marketed as effective at stopping and preventing bed bug infestations. In its complaint, the FTC alleged that the company violated a 2013 Commission order barring it from making scientifically unsupported claims. Rust Consulting, Inc., the refund administrator for this matter, will

mail refund checks to eligible consumers starting today. The checks must be cashed by August 31, 2018 or they become void. Consumers with questions about this refund program can call Rust Consulting at 1-877-906-1610.

# **Fraudulent cosmetics** and "anti-aging" products

he volume of counterfeit cosmetics arriving in the U.S. is on the rise. The Internet has given consumers widespread access to health and beauty products—some labeled with "anti-aging" properties—that they don't know are fake

Government and industry studies and testing have discovered dangerous ingredients within counterfeit "anti-aging" products. Fraudulent cosmetics may contain arsenic, beryllium, and cadmium—all known carcinogens-along with high levels of aluminum and dangerous levels of bacteria from sources such as urine. Some of these products have caused conditions like acne, psoriasis, rashes, and eye infections.

#### Tips for Avoiding Fraudulent "Anti-Aging" Products:

- Watch out for "secret formulas" or "breakthroughs."
- Find out exactly what it should and should not do for you.
- Research a product thoroughly before buying it.
- Be wary of products that claim to cure a wide variety of illnesses—particularly serious ones—that don't appear to be related.
  - Be aware that testimonials are often misleading.
  - Be very careful of products that are marketed as having no side
- effects.
- Question products that are advertised as making visits to a physician unnecessary.
