\$170 million to settle alleged violations of Children's Privacy Law

FTC, NEW YORK ATTORNEY GENERAL ALLEGE YOUTUBE CHANNELS COLLECTED KIDS' PERSONAL INFORMATION WITHOUT PARENTAL CONSENT

oogle LLC and its subsidiary YouTube, LLC will pay a record \$170 million to settle allegations by the Federal Trade Commission and the New York Attorney General that the YouTube video sharing service illegally collected personal information from children without their parents' consent.

The settlement requires Google and YouTube to pay \$136 million to the FTC and \$34 million to New York for allegedly violating the Children's Online Privacy Protection Act (COPPA) Rule. The \$136 million penalty is by far the largest amount the FTC has ever obtained in a COPPA case since Congress enacted the law in 1998. In a complaint filed against the companies, the FTC and New York Attorney General allege that YouTube violated the COPPA Rule by collecting personal information—in the form of persistent identifiers that are used to track users across the Internet—from viewers of child-directed channels, without first notifying parents and getting their consent. YouTube earned millions of dollars by using the identifiers, commonly known as cookies, to deliver targeted ads to viewers of these channels, according to the complaint.


The COPPA Rule requires that child-directed websites and online

services provide notice of their information practices and obtain parental consent prior to collecting personal information from children under 13, including the use of persistent identifiers to track a user's Internet browsing habits for targeted advertising. In addition, third parties, such as advertising networks, are also subject to COPPA where they have actual knowledge they are collecting personal information directly from users of child-directed websites and online services.

"YouTube touted its popularity with children to prospective corporate clients," said FTC Chairman Joe Simons. "Yet when it came to complying with COPPA, the company refused to acknowledge that portions of its platform were clearly directed to kids. There's no excuse for YouTube's violations of the law."

The YouTube platform allows Google account holders, including large commercial entities, to create "channels" to display their content. According to the complaint, eligible channel owners can choose to monetize their channel by allowing YouTube to serve behaviorally targeted advertisements, which generates revenue for both the channel owners and YouTube

Asking their backing to restore the people's trust in government, the President said, "I welcome you aboard with a challenge to go beyond selfish personal interests so that you may focus on the tasks waiting for you in your respective agencies."

"Work with this administration in ensuring that our bureaucracy is free of graft and corruption, red tape, and other illegal activities. Uphold the primacy of the Constitution, obey all laws, and observe due

process in the performance of your duties."

He also asked them to remain committed to the shared task of nation-building, noting that with their active participation in good governance, the administration can achieve a better life and a brighter future for Filipinos.

Hurricane Dorian's impact on the Bahamas

he Bahamas has been directly impacted by Hurricane Dorian — first as a Category 5 hurricane beginning 31st August, 2019, and lingering over Grand Bahama with a forward motion of a mere 2 mph for days before picking up speed on the evening of 3rd September. The all clear was given on the morning of 4th September 2019.

First to receive the impact was the island of Abaco, which endured winds of 185 mph and heavy rainfall and storm surge. The combined effects of the winds and the storm surge resulted in loss of life, countless destroyed structures and extreme flooding. Many shelters

had to be evacuated. The slow motion of the hurricane resulted in the tropical storm feeder bands on the back of the hurricane causing flooding to the island of New Providence and the need to open shelters there. The Prime Minister advised that an estimated 60% of homes on Abaco were destroyed.

After almost three (3) days battering the Island of Grand Bahama, the all clear was finally issued early on the morning of 4th September 2019. Homes have been flooded, shelters compromised and untold damage has occurred

As of 9th September, the death toll stands at 45 and is expected to rise.



Secretary Perry stands for establishment of DOE artificial intelligence office

ASHINGTON, D.C.- U.S. Secretary of Energy Rick Perry announced the establishment of the DOE Artificial Intelligence and Technology Office (AITO). The Secretary has established the office to serve as the coordinating hub for the work being done across the DOE enterprise in Artificial Intelligence. This action has been taken as part of the President's call for a national AI strategy to ensure AI technologies are developed to positively impact the lives of Americans.

DOE-fueled AI is already being used to strengthen our national security and cybersecurity, improve grid resilience, increase environmental sustainability, enable smarter cities, improve water resource management, as well as speed the discovery of new materials and compounds, and further the understanding, prediction, and treatment of disease. DOE's National Labs are home to four of the top ten fastest supercomputers in the world, and we're currently building three next-generation, exascale machines, which will be even faster and more Al-capable computers.



"The world is in the midst of the Golden Age of Al, and DOE's world class scientific and computing capabilities will be critical to securing America's dominance in this field," said Secretary Perry. "This new office housed within the Department of Energy will concentrate our existing efforts while also facilitating partnerships and access to federal data, models and high performance computing resources for America's Al researchers. Its mission will be to elevate, accelerate and expand DOE's transformative work to accelerate America's progress in Al for years to come." - DOE

34 individuals charged for alleged West Coast Medicare and Medicaid fraud schemes totaling \$258 million

ssistant Attorney General Brian A.
Benczkowski of the Justice Department's Criminal Division announced a health care fraud enforcement action in the state of California, involving charges brought against a total of 26 individuals in the Central District of California for their alleged involvement in Medicare and Medicaid fraud schemes resulting in \$257 million in billings. Of those charged, 14 were doctors or medical professionals. In addition, in the states of Arizona and Oregon,

eight defendants, including three licensed medical professionals, have been charged with defrauding the Medicaid program out of over \$1 million. These cases were investigated by each state's respective Medicaid Fraud Control Units.

The charges announced today aggressively target schemes billing Medicare and Medicaid for services, testing and prescriptions that were not medically necessary or not actually provided to beneficiaries.

"The action shows that our ability to

detect and prosecute health care fraud grows more sophisticated with each passing day," said Assistant Attorney General Brian A. Benczkowski of the Justice Department's Criminal Division.

"Corruption drains dollars from private insurers and public programs such as Medicare and Medicaid," said U.S. Attorney Nick Hanna of the Central District of California. "This office will continue to hold accountable anyone — including medical professionals — who seek to bilk our nation's health care system."

NASA administrator explores potential Artemis collaborations with Japan

ASA Administrator Jim Bridenstine met with Hiroshi Yamakawa, president of the Japan Aerospace Exploration Agency (JAXA), on Sept. 24 in Tokyo to discuss future bilateral cooperation and JAXA's potential participation in NASA's Artemis program.

"Today, we have committed to continuing the close dialogue that has been the hallmark of collaboration between our two agencies," Bridenstine said. "The Moon is the first major step to putting astronauts on Mars. Expanding collaboration between NASA and JAXA to advance human lunar surface activities ultimately will lead to further exploration of Mars — something that will benefit not only our two countries, but all of humanity."

They identified several areas in which the United States and Japan can extend scientific and technological cooperation to advance sustainable exploration of the Moon, including on the lunar Gateway and the Moon's surface. They also discussed the possibility of NASA collaboration on JAXA's Smart Lander for Investigating the Moon (SLIM) mission, and JAXA's plans to launch CubeSats to launch on NASA's Artemis I mission.

Weathering the storm after Hurricane Dorian

he Abacos are a picturesque group of Bahamian islands and cays that form a 120-mile-long chain stretching over 650 square miles. Historically, the islands' economy was based on fishing and boatbuilding but in recent years, tourism and citrus farming formed the major source of livelihoods.

In ordinary times numerous tourists flock the islands whose sparkling blue waters are perfect for water sports and fishing. But these are no ordinary times. Since 1 September 2019, when Hurricane Dorian made landfall, tourism has been shattered.

The hurricane, the second strongest in the Atlantic on record and the strongest to ever hit The Bahamas, caused widespread destruction of property and infrastructure. According to the government, as of 15 September, 50 people lost their lives. With over 1,300 people still missing, the casualties are expected to rise.

On 8 September, the Joint Environment Unit of the UN Environment Programme (UNEP) and the Office for the Coordination of Humanitarian Affairs, deployed an expert, as part of the UN Disaster Assessment and Coordination team sent to support the response, to conduct a rapid environmental assessment following the disaster.

Since its inception in 1994, the Joint Environment Unit has mobilized experts and equipment to over 200 emergencies globally, backed by a strong international network of partners. It has continuously worked to address and mitigate the negative environmental impacts of sudden-onset disasters and complex emergencies.

arge parts of South America have been affected by forest fires in the Amazon, ■including Bolivia. More than 4 million hectares of the Amazon forest already went up in flames. Over 2000 firefighters were deployed throughout the entire area. These are the most devastating fires of the past ten years and the difficult month of September has only just begun. The Bolivian authorities therefore asked the international community for help. Our country offers relief supplies through a coordination mechanism of the European Commission. Other Furonean countries such as France, Switzerland and Austria also decided to send specialised assistance. Today, 336 tents, 14 generators and 672 mosquito nets will be sent to the affected area. These goods will help the rescue workers of Bolivia's Civil Protection in their fight against the forest fires.

The Federal Public Service (FPS) Foreign Affairs coordinates the B-FAST mission. The Belgian embassy in Lima (Peru) will ensure the supplies are delivered properly in Santa Cruz. Development Cooperation, Defence, the FPS Home Affairs, the FPS Policy and Support (BOSA) and the FPS Public Health provide logistic and administrative assistance.

February 2003, B-FAST (Belgian First Aid and Support Team) is the rapid intervention unit of the federal government in case of disasters abroad. SCG and Dow team up on plastic recycling

ow Chemical of the U.S. and SCG have agreed to collaborate on a feasibility study on a plastic waste recycling and renewable feedstock facility in Thailand's fast-growing Eastern Economic Corridor (EEC).

"This collaboration expects to operate mechanical and feedstock recycling from plastic resins, plastic waste, and petrochemical feedstocks," said Roongrote Rangsiyopash, CEO and President of SCG, the region's largest building materials company.

"It is a business opportunity for SCG and Dow to embrace the circular economy concept, bringing practical solutions for recycling and upcycling of plastic waste to Thailand," he added.

SCG has become the leading private-sector proponent of adopting the Circular Economy in Thailand. In the Linear Economy that has dominated history, people take natural resources and turn them into products that eventually end up on the trash heap. But these days, resources are dwindling, and the trash is becoming unmanageable.

In the Circular Economy, people use natural resources more responsibly and sparingly to make products that can be recycled or broken down so their elements can be reused. The Circular Economy is an essential model in sustainable development.

Jim Fitterling, Dow's chief executive, said the company could provide its recycling technologies to support more collaborative ventures in Thailand.

"The plastics are too valuable to be lost as waste, so they should be a part of the circular economy concept. Dow expects that plastic waste locally can be recycled for this operation at roughly 200,000-300,000 tons per year in the near future," he said.

Dow also partners with SCG to make roads using a new form of asphalt that has plastic waste mixed in. Studies have shown the roads to be more durable, stable, and water-resistant.

European Commission and WHO join forces to promote the benefits of vaccines

he European Commission and the World Health Organization (WHO) co-hosted the world's first Global Vaccination Summit in Brussels last September 12. The aim was to accelerate global action to stop the spread of vaccine-preventable diseases, and advocate against the spread of vaccine misinformation worldwide.

Jean-Claude Juncker, President of the European Commission, said: "It is inexcusable that in a world as developed as ours, there are still children dying of diseases that should have been eradicated long ago. Worse, we have the solution in our hands but it is not being put to full use. Vaccination already prevents 2-3 million deaths a year and could prevent a further 1.5 million if global vaccination coverage improved. Today's summit is an opportunity to address this gap. The Commission will continue to work with the EU's Member States in their national efforts and with our partners here today. This is a global challenge we must tackle together, and now."

Dr Tedros Adhanom Ghebreyesus, Director-General of the World Health Organization, said: "After many years of progress, we are at a critical turning point. Measles is resurging, and 1 in 10 children continues to miss out on essential childhood vaccines," said Dr Tedros, "We can and must get back on track. We will only do this by ensuring everyone can benefit from the power of vaccines — and if governments and partners invest in immunization as a right for all, and a social good. Now is the time to step up efforts to support vaccination as a core part of health for all."

During the summit opening, President Juncker and Dr Tedros called for an urgent intensification of efforts to stop the spread of vaccine-preventable diseases such as measles. In the past 3 years, 7 countries, including 4 in the European region, have lost their measles elimination status. New



outbreaks are the direct result of gaps in vaccination coverage, including amongst teenagers and adults who were never fully vaccinated. To tackle vaccination gaps effectively, the summit addressed the multiple barriers to vaccination, including rights, regulations and accessibility, availability, quality and convenience of vaccination services; social and cultural norms, values and support; individual motivation, attitudes, and knowledge and skills.

The European Commission and the World Health Organization also urged for strong support of GAVI, the Global Vaccine Alliance. GAVI plays a critical role in achieving the global vaccine goals in the world's least-resourced countries.

New models and opportunities for stepping up vaccine development are also on the Global Vaccination Summit agenda, as well as ways to ensure that immunisation is a public health priority and a universal right. - Source: European Commission

VIET NAM RESOLUTELY TAKES STRICT MEASURES TO HANDLE TRADE FRAUDS

ANOI -- Viet Nam resolutely prevents and strictly deals with trade and origin frauds in the domestic market as well as in import-export activities, aiming to protect the legitimate interests of local businesses and consumers, according to Foreign Ministry spokesperson Le Thi Thu Hang.

Hang said that the Prime Minister has

approved a project on strengthening State management over the prevention of trade remedies evasion and origin frauds.

The Government leader has directed relevant ministries and agencies to drastically and synchronously implement many measures to raise awareness and enhance State management over export-import activities and foreign



Red Cross commits \$4.5M to help Dorian victims in the Bahamas

There's a long road ahead for people in the Bahamas who have lost everything to Hurricane Dorian and the American Red Cross has committed \$4.5 million to support those affected.

The American Red Cross has also deployed 21 disaster response specialists to provide support to the relief operation in the Bahamas and worked in close coordination with partners to support evacuees who arrived in the United States from the Bahamas immediately following the hurricane.

Thousands of people have evacuated the damaged islands via helicopter, plane and boat. They are staying on different islands with family members or at government-run shelters in the capital city.

Families who remain on the devastated islands are in need of basic relief, such as emergency shelter supplies and hygiene items—which Red Cross teams are distributing on both Abaco and Grand Bahama. Red Cross shelter, water and sanitation, health, logistics, cash-as-aid and other sec-

tor specialists are on the ground supporting the Bahamas Red Cross.

Aid is also being delivered to storm survivors in places not majorly affected by the storm, such as Nassau, where Bahamas Red Cross volunteers are helping evacuees by distributing relief items to shelters including water, hygiene items, dried food parcels other supplies and food vouchers. As with any disaster, there are challenges to delivering aid such as damaged ports and airports, devastated infrastructure, and difficulties with tele-connectivity.

Tele-connectivity challenges mean that many people still haven't been able to get in touch with loved ones. In shelters, volunteers are helping evacuees make phone calls to their families. When necessary, volunteers are initiating missing persons cases with the hope of tracing loved ones. Trained psychologists and nurses are providing comfort and mental health support to evacuees coping with emotional distress. -- American Red Cross



How to protect your computer



The same advice parents might deliver to young drivers on their first solo journey applies to everyone who wants to navigate safely online. A special agent in the FBI's Cyber Division offered the following:

- "If you don't secure your computer, it's vulnerable."
- "Reduce your vulnerability, and you reduce the threat."

Below are some key steps to protecting your computer from intrusion:

KEEP YOUR FIREWALL TURNED ON

A firewall helps protect your computer from hackers who might try to gain access to crash it, delete information, or even steal passwords or other sensitive information. Software firewalls are widely recommended for single computers. The software is prepackaged on some operating systems or can be purchased for individual computers. For multiple networked computers, hardware routers typically provide firewall protection.

INSTALL OR UPDATE YOUR ANTIVIRUS SOFTWARE

Antivirus software is designed to prevent malicious software programs from embedding on your computer. Viruses can infect computers without users' knowledge. Most types of antivirus software can be set up to update automatically.

INSTALL OR UPDATE YOUR ANTISPYWARE TECHNOLOGY

Spyware is just what it sounds like—software that is surreptitiously installed on your computer to let others peer into your activities

on the computer. Some spyware collects information about you without your consent or produces unwanted pop-up ads on your web browser. Some operating systems offer free spyware protection, and inexpensive software is readily available for download on the Internet or at your local computer store. Be wary of ads on the Internet offering downloadable antispyware—in some cases these products may be fake and may actually contain spyware or other malicious code. It's like buying groceries—shop where you trust.

KEEP YOUR OPERATING SYSTEM UP TO DATE

Computer operating systems are periodically updated to stay in tune with technology requirements and to fix security holes. Be sure to install the updates to ensure your computer has the latest protection.

BE CAREFUL WHAT YOU DOWNLOAD

Carelessly downloading e-mail attachments can circumvent even the most vigilant anti-virus software. Never open an e-mail attachment from someone you don't know, and be wary of forwarded attachments from people you do know. They may have unwittingly advanced malicious code.

TURN OFF YOUR COMPUTER

With the growth of high-speed Internet connections, many opt to leave their computers on and ready for action. The downside is that being "always on" renders computers more susceptible. Beyond firewall protection, which is designed to fend off unwanted attacks, turning the computer off effectively severs an attacker's connection—be it spyware or a botnet.

Choosing a Credit Counselor

Most reputable credit counselors are non-profit and offer services at local offices, online, or on the phone. If possible, find an organization that offers in-person counseling. Many universities, military bases, credit unions, housing authorities, and branches of the U.S. Cooperative Extension Service operate non-profit credit counseling programs. Your financial

SLEEPINESS AND DRIVING DON'T MIX

eeling sleepy is especially dangerous when you are driving. Sleepiness slows your reaction time, decreases awareness and impairs your judgment, just like drugs or alcohol. People who are very sleepy behave in similar ways to people who are drunk. The impact that this has on traffic safety should not be underestimated.

To remain alert and avoid drowsiness, AAA suggests:

- Getting plenty of sleep (at least six hours) the night before a long trip;
- Traveling at times when you are normally awake, and staying overnight rather than driving straight through;
- Scheduling a break every two hours or every 100 miles;
- Stop driving if you become sleepy; someone who is tired could fall asleep at any time — fatigue impacts reaction time, judgment and vision, causing people who are very sleepy to behave in similar ways to those who are drunk;
- Drink a caffeinated beverage. Find a safe place to take a 20-30 minute nap while you're waiting for the caffeine to take effect;
- Avoid sleepy times of day. Take a mid-afternoon nap and find a place to sleep between midnight and 6 a.m.; and
 - Travel with an awake passenger.

institution, local consumer protection agency, and friends and family also may be good sources of information and referrals.

But be aware that "non-profit" status doesn't guarantee that services are free, affordable, or even legitimate. In fact, some credit counseling organizations charge high fees, which they made hide; others might urge their clients to make "voluntary" contributions that can cause more debt.

Choosing a Credit Counseling Organization

Reputable credit counseling organizations can advise you on managing your money and debts, help you develop a budget, and offer free educational materials and workshops. Their counselors are certified and trained in consumer credit, money and debt management, and budgeting. They discuss your entire financial situation with you, and help you develop a personalized plan to deal with your money problems. An initial counseling session typically lasts an hour,

with an offer of follow-up sessions.

A reputable credit counseling agency should send you free information about itself and the services it provides without requiring you to provide any details about your situation. If a firm doesn't do that, consider it a red flag and go elsewhere for help.

Once you've got a list of counseling agencies you might do business with, check each one out with your state Attorney General and local consumer protection agency. They can tell you if consumers have filed complaints about any one of them. (If there are no complaints about them, don't consider it a quarantee that they're legitimate.)

The United States Trustee Program also keeps a list of credit counseling agenciesap-proved to provide pre-bankruptcy counseling. After you've done your background investigation, you will want to interview the final "candidates."

How to avoid falling for a lottery or sweepstakes scam?

A lottery requires you to purchase a ticket in order to participate. If you did not enter to participate in a lottery, ignore any notices saying that you have won.

- Sweepstakes are free games of chance. Do not send money in advance in order to participate in a sweepstakes: It is illegal to require any payment or purchase to enter a sweepstakes or to increase your odds of winning.
- Do not send money to claim your prize. This includes requests to pay for taxes, shipping and handling, insurance, or processing fees
- Never provide your bank account number or other personal information. Since you are not required to pay to participate in a sweepstakes or receive a prize, there is no need to give out this private information.
- Know who is allowed to contact you about winning:
- D.C. Lottery will only contact winners who entered into a D.C. Lottery-sponsored promotional game. If you did not enter the



lottery, do not provide any information.

- No foreign entity may contact you about winning their lottery. Since it is illegal to participate in foreign lotteries, you should not pay or give any private information to any person claiming that you have won.
- No federal or District government employee will ever contact you about winning the lottery or a sweepstakes, so do not provide any information to people claiming to work for a government entity that provides prizes.
- Don't be afraid to hang up if you feel pressured, if the caller is not answering your questions, or if you simply don't get a "good feeling" about the caller.

DOT, Emirates join hands to boost Philippines tourism from EU, ME source markets

The Philippine Department of Tourism (DOT) and Emirates Airline recently inked a memorandum of agreement (MOA) that aims to assert the Philippines' presence in the European, Middle East and other international markets being serviced by the Dubai-based airline.

Joint marketing efforts will focus on branded advertising and promotional campaigns targeting Europe inbound traffic to the Philippines. The two parties will also utilize digital marketing strategies tapping into the different social media platforms and other e-marketing campaign initiatives to assert the Philippines' presence in the international travel market.

Another focus of the partnership is the people-to-people exchanges, particularly to attract Europe-based consumers, trade and media agents by launching familiarization trips and tours in the

Philippines. Under the agreement, both parties will also engage in joint roadshows, bringing together Philippine industry and key market trade partners, to boost opportunities for trade.

DOT Undersecretary Benito C. Bengzon, Jr. said that this agreement is a welcome development as the DOT works to improve air connectivity from long-haul countries in Europe and the Middle East, considering Emirates flies to more than 40 destinations in Europe and operates more than 250 flights per day globally. "It is widely known that long-haul source markets provide more benefits not only for tourism but also to hotel and resort operators, travel facilitators and other stakeholders as studies show that travelers from these markets stay longer and spend more," he further explained the yields from this partnership.



During their time here, the generals met with key policymakers, including Undersecretary of National Defense Cardozo Luna, Chief of Staff of the Armed Forces of the Philippines Benjamin Madrigal, and the Commanding General of the Philippine Air Force Rozzano Briguez.

US and PHL Armed Forces Combined Airborne Operation



Soldiers from the US 4th Infantry Brigade Combat Team (Airborne), 25th Infantry Division, and the Armed Forces of the Philippines (AFP) conducted a bilateral airborne operation from September 19 to 25. This type of combined, tactical-level training builds both forces' technical competence, fosters interoperability, and provides a greater understanding of how the allied nations' forces conduct operations.

US Government Provides Infrastructure and Livelihood Support to Benefit Displaced Maranao



U.S. Embassy Chargé d'Affaires John C. Law addressed the U.S. government-supported 28th Mindanao Business Conference, where he underscored the long-standing partnership between the U.S. and Mindanao, led the handover ceremonies of community grants and a public market, and toured Mindanao State University Iligan Institute of Technology's Fab Lab. The lab was made possible through donations from multiple donors, including the U.S. Department of State.

The U.S. government, through the United States Agency for International Development (USAID), turned over 80 transitional houses, a climate-resilient public market, and four grants that will provide infrastructure and livelihood support to communities displaced by the 2017 Marawi Siege. The assistance is part of the U.S. government's commitment of more than \$63.6 million (Php3.4 billion) worth of humanitarian and recovery assistance to persons displaced by the siege. U.S. Embassy Chargé d'Affaires John C. Law led the handover ceremonies of the community grants and public market.

EducationUSA Roadshow Coming to Cordillera

In celebration of National Literacy Month, EducationUSA will conduct a roadshow in Cordillera from September 11 to 14 to engage Filipinos interested in studying in the United

Education USA advisors will visit high schools and colleges to conduct information sessions, essay workshops, and one-on-one advising, and spread the word about Education USA's free services to teach U.S. college application literacy to aspiring international students

In collaboration with the Aviation Institute of Maintenance (AIM), an accredited U.S. institution that provides practical and professional aviation skills education, EducationUSA conducted an interactive workshop and discussion on U.S. aviation studies programs for 75 Filipino students and professionals at the U.S. Embassy in the Philippines last August 30.

The event is part of Education USA's Enrichment Series, a free, yearlong set of monthly programs designed to help prospective applicants make well-informed choices when choosing a university abroad at any point in their academic career.
