

FBI arrests Filipino church leaders in immigrant trafficking scam

AUTHORITIES SAY CHURCH MEMBERS WERE FORCED TO COLLECT DONATIONS

The FBI arrested three administrators of a Filipino-based church Wednesday for allegedly trafficking in its members from Asia as part of a six-year fundraising scam.

Guia Cabactulan, 59, Marissa Duenas, 41, and Amanda Estopare, 48, who are members of the Kingdom of Jesus Christ, the Name Above Every Name (or KOJC), were picked up by agents in California and Virginia following raids of KOJC's offices in Van Nuys, Glendale and Los Angeles, the FBI said.

The three allegedly used a children's foundation as a front to bring in its members from the Philippines and use them to beg for money on the street, the criminal complaint said.

KOJC was created in 1985 in Davao, Philippines, by Apollo Quiboloy who claims to be "the Appointed Son of God."

Investigators said as early as October 2013, the church would obtain visas for its

members under the pretense that they would be performing in musical events in America, however once those members got to the country, they had their passports taken away and were forced to work as "volunteers," to raise money. The workers were allegedly sent to various locations across the country and ask for money that they claimed went to aid Filipino children, according to the criminal complaint.

The money, in reality, went to church operations, and between 2014 and mid-2019, KOJC collected close to \$20 million from these donations, the FBI said. Workers were allegedly ordered to meet quotas that changed daily while they were collecting the donations, according to the complaint.

KOJC administrators allegedly used several illicit tactics to keep workers in the country including sham marriages and phony enrollments in schools, and forced them to live in unsafe living conditions, according to the FBI.

Several workers came forward to the FBI and gave them details accounts of their experiences as well as e-mails from their administrators that detailed their instructions in the alleged scam, the agency said.

Cabactulan, who was the top U.S. KOJC administrator and had direct communications with leaders back in the Philippines, allegedly held on to the victims' passports and oversaw the operations, according to the complaint. The FBI said Duenas was responsible for falsifying documents and information to immigration officials, while Estopare was allegedly in charge of the collections, according to the complaint.

The church has come under scrutiny by federal investigators in the past. In September, a Hawaii manager of KOJC was charged with smuggling cash to the Philippines using Quiloboly's private jet, according to the FBI. Quiboloy was briefly arrested in Hawaii in 2018 after federal agents found \$350,000 in cash and parts to assemble a military rifle were found in his jet.

The FBI has established a toll-free phone number for potential victims or anyone with information about KOJC activities to provide information,1-800-CALL FBI (1-800-225-5324). FBI operators fluent in English and Tagalog will staff the hotline.

PUBLIC HEALTH SCREENING TO BEGIN AT 3 U.S. AIRPORTS FOR CORONAVIRUS

The Centers for Disease Control and Prevention (CDC) and the Department of Homeland Security's Customs and Border Protection (CBP) will implement enhanced health screenings to detect ill travelers traveling to the United States on direct or connecting flights from Wuhan, China. This activity is in response to an outbreak in China caused by a novel (new) coronavirus (2019 nCoV), with exported cases to Thailand and Japan.

Since January 17, 2020, travelers from Wuhan to the United States undergo entry screening for symptoms associated with 2019nCoV at three U.S. airports that receive most of the travelers from Wuhan, China: San Francisco (SFO), New York (JFK), and Los Angeles (LAX) airports.

Based on current information, the risk from 2019-nCoV to the American public is currently deemed to be low. Nevertheless, CDC is taking proactive preparedness precautions. Entry screening is part of a layered approach used with other public health measures already in place to detect arriving travelers who are sick to slow and reduce the spread of any disease into the United States. CDC has deployed about 100 additional staff to the three airports (SFO, JFK, and LAX) to supplement existing staff at CDC quarantine stations located at those airports. CDC is actively monitoring this situation for pertinent information about the source of outbreak, and risk for further spread through person-to-person or animal-to-person transmission. CDC may adjust screening procedures and other response activities as this outbreak investigation continues and more is learned about the newly emerging virus. Entry screening alone is not a guarantee against the possible importation of this new virus but is an important public health tool during periods of uncertainty. As new information emerges, CDC will reassess entry screening measures and could scale activities up or down accordingly.

NBA legend, daughter dies in helicopter crash

NBA All - Star Kobe Bryant and his 13 year old daughter, Giana (Gigi), died in a helicopter crash with seven other people — Ara Zobayan, Sarah and Payton Chester, Christina Mauser, and Keri, Alyssa, and John Altobelli — in Calabasas, CA, on Jan. 26.

Kobe was headed to a youth basketball game in Thousand Oaks when the helicopter crashed "amid foggy conditions into a hillside near an intersection in area north of Malibu State Park" and a brush fire erupted. There were no survivors.

It has been reported that Kobe Bryant and his daughter Gianna attended a 7 a.m. Catholic mass and received communion on Sunday atting thedral of Our Lady Queen of the Angels in Newpon Beach, Calif. After Mass, the father and daughter headed to Gianna's basketball game at the Mamba Sports Academy.

On January 30, the World Health Organization determined the rapidly spreading outbreak constitutes a Public Health Emergency of International Concern. Travelers should be prepared for travel restrictions to be put into effect with little or no advance notice. Commercial carriers have reduced or suspended routes to and from China.

Those currently in China should consider departing using commercial means. The Department of State has requested that all non-essential U.S. government personnel defer travel to China in light of the novel coronavirus.

In an effort to contain the novel coronavirus, the Chinese authorities have suspended air, road, and rail travel in the area around Wuhan and placed restrictions on travel and other activities throughout the country. On January 23, 2020, the Department of State ordered the departure of all non-emergency U.S. personnel and their family members from Wuhan. The U.S. government has limited ability to provide emergency services to U.S. citizens in Hubei province. On January 29, 2020, the Department of State allowed for the voluntary departure of non-emergency personnel and family members of U.S. government employees from China. On January 31, 2020, the Department of State ordered the departure of all family members under age 21 of U.S. personnel in China.

The Justice Department announced that it has filed a lawsuit alleging that female tenants in residential apartment buildings in Los Angeles, California, were subjected to sexual harassment and retaliation in violation of the federal Fair Housing Act.

The lawsuit, filed in the U.S. District Court for the Central District of California, alleges that property manager Filomeno Hernandez sexually harassed female residents at the rental properties since at least 2006 through the present. The apartment buildings are located at 729 South Bonnie Brae Street and 720 Westlake Avenue, near MacArthur Park. The Department's complaint names Filomeno Hernandez, Ramin Akhavan, Bonnie Brae Investment Services LLC, and Westlake Property Services LLC as defendants. Defendants manage or own properties where the illegal conduct occurred.

PHL Embassy repatriates Filipinos from Haiti

WASHINGTON, D.C. – The Philippine Embassy's Deputy Chief of Mission Renato Pedro O. Villa and Assistance-to-Nationals Officer Ryan Dasal were in Haiti on 11-14 January 2020 to assist in the repatriation of 30 Filipino nationals, composed of 9 minors and 21 adults, to the Philippines.

The Filipino community in Haiti petitioned the said repatriation because of the unstable economic and security situations in the country, caused by continuous civil unrest, crime, and kidnapping.

Most of the minor repatriates will continue their studies in the Philippines.

The repatriates were divided into two (2)

groups – the Philippine Airlines (PAL) group which is composed of 17 repatriates, and Asiana Airlines group which is composed of 13 repatriates. Both groups arrived in the Philippines on Janury 16, 2020.

"Ensuring the safety and well-being of our overseas Filipinos remain a top priority of the Philippine Government. The Philippine Embassy, along with the Philippine Consulates **General and Honorary Philippine Consulates** in the United States and in the Caribbean, are always here to listen and provide assistance to our kababavansas the need arises," Philippine Ambassador to the United States Jose Manuel G. Romualdez said in a separate statement.

US Ambassador Kim announces Php 5.1M in relief assistance for communities affected by Taal Volcano

NASUGBU, Batangas— During a visit to a school serving as an evacuation center in Nasugbu, Batangas on January 22, U.S. Ambassador to the Philippines Sung Y. Kim announced the provision of Php 5.1 million (\$100,000) in U.S. government support to those affected by the January 12 Taal volcanic eruption. Ambassador Kim also joined Philippine Disaster Resilience Foundation (PDRF) partners to distribute supplies to evacuees in Calatagan.

With this new funding, the United States government, through U.S. Agency for International Development (USAID) partner World Vision, is providing relief supplies including soap, sleeping mats, and blankets, to nearly 7,600 people in the Nasugbu West Central School evacuation center in Batangas

While at the evacuation site, the Ambassador spoke with families who were forced to evacuate their homes. "I'm inspired by the strength and resilience of these families who faced such devastation and loss following the volcanic eruption. As friends, partners, and allies to the Philippines, we will continue to support our Philippine government counterparts as they work to address the needs of those communities most affected by the eruption."

In Calatagan, Ambassador Kim thanked PDRF companies for their assistance to evacuees. "I have been very encouraged to see the private



sector – American companies alongside Philippine companies – mobilize to address urgent needs of communities following the Taal volcanic eruption." PDRF is a major private sector vehicle and coordinator for disaster management in the Philippines.

This newly announced U.S. assistance complements existing support to transport emergency supplies to evacuees, provide technical assistance to manage evacuation centers, and loan specialized equipment and analytic support to monitor the Taal volcano.



A volcano is an opening in the Earth's crust that allows molten rock, gases, and debris to escape to the surface. Alaska, Hawaii, California, and Oregon have the most active volcanoes, but other states and territories have active volcanoes, too. A volcanic eruption may involve lava and other debris that can flow up to 100 mph, destroying everything in their path. Volcanic ash can travel 100s of miles and cause severe health problems. A volcanic eruption can:

- · Contaminate water supplies.
- Damage machinery.

• Reduce visibility through smog and harmful gases that may threaten low-lying areas.

· Make it hard to breathe and irritate the skin, eyes, nose, and throat.

IF YOU ARE UNDER A VOLCANO WARNING:

• Listen for emergency information and alerts.

· Follow evacuation or shelter orders. If advised to evacuate, then do so early.

Avoid areas downstream of the eruption

- Protect yourself from falling ash.
- · Do not drive in heavy ash fall.

HOW TO STAY SAFE WHEN A VOLCANO **THREATENS:**

Prepare NOW

• Know your area's risk from volcanic eruption.

· Ask local emergency management for evacuation and shelter plans, and for potential means of protection from ash.

FTC says "Success By Health" is a pyramid scheme

Do we have your attention? Good! Are you rolling your eyes? Even better. That means you've heard warnings about illegal pyramid schemes that masquerade as legitimate multilevel marketing (MLM) businesses and promise life-changing income, but take your money instead.

The FTC's latest case charging a company with operating a pyramid scheme concerns "Success By Health" (SBH), a venture that the FTC alleges has bilked consumers who joined its sales network as "Affiliates" out of more than \$7 million.

According to the FTC, SBH tells consumers they can replace their job income in six months and gain "financial freedom" in 18 months by selling its coffee, tea, and dietary supplements and recruiting other people to do the same. In

The Centers for Disease Control and Prevention (CDC) has a list of certified masks and the maker's instructions on how to use the masks.

 Avoid driving in heavy ash fall. Be Safe AFTER

Listen to authorities to find out when it is safe to return after an eruption.

· Send text messages or use social media to reach out to family and friends. Phone systems are often busy after a disaster. Only make emergency calls.

 Avoid driving in heavy ash. Driving will stir up volcanic ash that can clog engines and stall vehicles.

• If you have any breathing problems, avoid contact with ash. Stay indoors until authorities say it is safe to go outside.

• Do not get on your roof to remove ash unless you have guidance or training. If you have to remove ash, then be very careful as ash makes surfaces slippery. Be careful not to contribute additional weight to an overloaded roof. - ready.gov

The Department announced a proposed rule ensuring the equal treatment and constitutional rights of religious organizations and faith-based institutions, as well as First Amendment freedoms owed to students on campus. As directed by Congress, the agency will also release updated guidance regarding constitutionally protected prayer in schools.

"Our actions today will protect the constitutional rights of students, teachers, and faith-based institutions," said Secretary DeVos. "The Department's efforts will level the playing field between religious and non-religious organizations competing for federal grants, as well as protect First Amendment freedoms on campus and the religious liberty of faith-based institutions. I proudly share President Trump's commitment to religious freedom and the First Amendment."

In a separate action, for the first time since 2003, the Department also issued updated guidance on constitutionally protected prayer in public elementary and secondary schools.





The complaint alleges that SBH pushes Affiliates to max out their credit cards, borrow from family, get bank loans, and sell or mortgage their homes to buy inventory and attend costly "training" programs. But, according to the FTC, the amount Affiliates earn is based on how many new Affiliates they recruit and how much inventory they and their recruits buy, not on their sales of SBH products to retail customers. At the FTC's request, a federal court has ordered SBH to halt its allegedly unlawful activities while the case is pending.

If you're planning to buy into an MLM plan, get the details. Start by searching online for the name of the company and words like review, scam, or complaint. Be skepticalof portrayals of lavish lifestyles made possible by participating in the program. And, if promoters emphasize recruiting as the real way to make money, head for the nearest exit. That's a hallmark of a pyramid scheme.

Even though many residents of a typical American college town might move away after they graduate, they have to be counted while they live there.

College towns across the country depend on students' responses to the census. The reason: Census results help determine how much federal funding communities will receive over the next 10 years. A complete and accurate count in 2020 is so important that the U.S. Census Bureau is hiring an estimated 500,000 temporary employees to ensure everyone is counted.

Students in college towns use critical local resources, including roads, public transportation and health clinics. Getting funds for those resources, however, depends on making sure students are counted in the right place each census. When responding to the 2020 Census, college students should be counted where they live and sleep most of the time as of April 1, 2020. For most students, that means in their college town, not back home with their parents.

Parents or guardians should only include children in college who live with them full time during the school year. weight loss products.

• To lose weight, all you have to do is take this pill. (Not true.)

• You can lose 30 pounds in 30 days. (Nope.)

This product works for everyone. (It doesn't.)
 Lose weight with this patch or cream.

(You can't.) Here's the truth:

Any promise of miraculous weight loss

is simply untrue.

 There's no magic way to lose weight without a sensible diet and regular exercise.
 No product will let you eat all the food

you want and still lose weight.

Permanent weight loss requires
permanent lifestyle changes, so don't trust any
product that promises once-and-for-all results.

 FDA-approved fat-absorption blockers or appetite suppressants won't result in weight loss on their own; those products are to be taken with a low-calorie, low-fat diet and regular exercise.

• Products promising lightning-fast weight loss are always a scam. Worse, they can ruin your health.

• Even if a product could help some people lose weight in some situations, there's no one-size-fits-all product guaranteed to work for everyone. Everyone's habits and health concerns are unique.

• Nothing you can wear or apply to your skin will cause you to lose weight. Period. - FTC

Getting your credit report

Now that you know why credit matters, it's time to get your credit in order. Sometimes the hardest part is getting started. The first step is to pull your credit report.

How do you get your credit report? Request a free copy at annualcreditreport.com or by calling 1-877-322-8228. Other sites may charge money or may be set up to steal your personal information.

Here's what to expect when you go to annualcreditreport.com: First, you'll fill out a form with your name, birth date, and Social Security number. Make sure you're using a secured internet connection, like at home – not public Wi-Fi.

Next, you'll pick which reports you want. You're entitled to a free report each year from each of the nationwide credit bureaus – Equifax, Experian, and TransUnion. Sometimes one bureau will have slightly different information than the others. So, you'll want to make sure all three reports are accurate. You can get the reports all at once or stagger your requests to keep an eye on things throughout the year. The choice is up to you.

Last, you'll answer questions about the

person you know best – you. They may be about prior addresses, loans, or other personal information. This is to make sure that it's really you ordering your report. If you have trouble with the online questions, you can call 1-877-322-8228.

Then, you'll get a copy of your credit report. You can look at it then or download it to review later. Just remember to keep the report stored securely – either under lock and key if it's paper, or on a password-protected device if it's digital.

SYMPTOMS AND DIAGNOSIS

Symptoms

Common human coronaviruses, including types 229E, NL63, OC43, and HKU1, usually cause mild to moderate upper-respiratory tract illnesses, like the common cold. Most people get infected with these viruses at some point in their lives. These illnesses usually only last for a short amount of time. Symptoms may include: runny nose, headache, cough, sore throat, fever, and a general feeling of being unwell

Human coronaviruses can sometimes cause lower-respiratory tract illnesses, such as pneumonia or bronchitis.

This is more common in people with cardiopulmonary disease, people with weakened immune systems, infants, and older adults.

TRANSMISSION

Human coronaviruses most commonly spread from an infected person to others through

- the air by coughing and sneezing
- close personal contact, such as touching or shaking hands

• touching an object or surface with the virus on it, then touching your mouth, nose, or eyes before washing your hands

• rarely, fecal contamination

In the United States, people usually get infected with common human coronaviruses in the fall and winter. However, you can get infected at any time of the year. Most people will get infected with one or more of the common human coronaviruses in their lifetime. Young children are most likely to get infected. However, people can have multiple infections in their lifetime.

PREVENTION AND TREATMENT

Prevention: How to protect yourself

There are currently no vaccines available to protect you against human coronavirus infection. You may be able to reduce your risk of infection by doing the following

- wash your hands often with soap and water for at least 20 seconds
- avoid touching your eyes, nose, or mouth with unwashed hands
- avoid close contact with people who are sick

For information about hand washing, see CDC's Clean Hands Save Lives! *How to protect others*

If you have cold-like symptoms, you can help protect others by doing the following

- stay home while you are sick
- avoid close contact with others

• cover your mouth and nose with a tissue when you cough or sneeze, then throw the tissue in the trash and wash your hands

- clean and disinfect objects and surfaces
- Treatment

There are no specific treatments for illnesses caused by human coronaviruses. Most people with common human coronavirus illness will recover on their own. However, you can do some things to relieve your symptoms

- take pain and fever medications (Caution: do not give Aspirin to children)
- use a room humidifier or take a hot shower to help ease a sore throat and cough If you are mildly sick, you should
- drink plenty of liquids
- stay home and rest



Awee Abayari: How did you start your business in the hospitality industry?
